# ASPER CHAIR VISION FOR 2007-2008



**Bryan Schwartz, Asper Chair** 

The creation of the The Marcel A. Desau-I tels Centre for Private Enterprise and the Law is a breakthrough development for Robson Hall. We at the Asper Chair intend to work closely with John Pozios, the experienced and talented first Director of the Desautels Centre, to find opportunities to pool our resources and ideas. John Pozios and I are exploring the possibility of a joint graduate program in law and business. Building on an initial collaboration that resulted in last year's symposium on the future of the Canadian Wheat Board, our major joint project for 2007-08 will be next spring's international symposium on franchise law, which will bring lessons from around the world to the very practical question of whether Manitoba should proceed with its own franchise legislation. Following the May 2007 release of the Manitoba Law Reform Commissions' "Consultation Paper on Franchise Law," franchise symposium assistant Leandro Zylberman has assisted us in drafting a policy-based response, to be accompanied by a survey of franchise legislation around the world.

This winter, Mary Shariff, a highly promising new appointment to the faculty, will be teaching the International Business Law course inaugurated when the Asper Chair was created in 1999. Meanwhile, I will be working on developing a new course in e-commerce. Eventually, it is hoped that Mary and I will be able to alternate in teaching this tandem of courses, which, along with the International Trade Law course, form the core of the teaching program offered by the Asper Chair.

Among my own research directions in the international business and trade area will be to continue working on the problem of the recognition of foreign professional and vocational credentials in Canada. Manitoba appears poised to take a first step in addressing this issue this fall, when it enacts its own *Fair Registration Practices in Regulated Professions Act*.

In response to the countries (Canada and the United States included) that have been studying resolutions in favour of referring Iranian President Mahmoud Ahmadinejad to the U.N. Security Council for incitement to genocide, Asper Chair research assistant Chris Donaldson and I have been studying whether such an indictment could be successful.

With regards to the Asper Review, I have been developing a website, which will include information about past and current issues, the submission process, international business and trade courses at Robson Hall, and the Asper Review Prize, which was inaugurated this past year.

This past summer I had the pleasure of working with one of the strongest cadre of summer research students I have ever seen. The new Shelley M. Weiss Publications Office has proved to be a happily collegial and productive environment for them.

### FRANCHISE LAW SYMPOSIUM COMING SOON

Manitoba's franchise industry currently faces a fundamental change in is legal environment: the prospect of having franchise legislation introduced in the province. Franchises are regulated all over the world, with legislation demanding pre-contract disclosure, registration, and imposing the right of association and the duty of good faith and fair dealing. Thus far, only three provinces in Canada have introduced such legislation. The Manitoba Law Reform Commission is in the process of reviewing suggestions as to what Manitoba should do.



The Asper Chair of International Business and Trade Law, in conjunction with the Marcel A. Desautels Centre for Private Enterprise and the Law, will be hosting a franchise symposium in March of 2008. The symposium will deal with important topics to franchising, including whether Manitoba needs franchise legislation and how it should be framed, in light of lessons learned from other jurisdictions. The organizers hope to attract speakers from Canada, the U.S., and beyond, including corporate leaders as well as leading legal academics and practitioners. Ample opportunity will be provided for audience participation.

This is an exciting time for franchising as Manitoba has the opportunity to craft an innovative statute informed by the experiences of other jurisdictions. More information will be provided as the symposium date draws near.

#### IRANIAN INDICTMENT MOVING THROUGH PARLIAMENT

In a series of statements that have shocked the world and brought global condemnation, Mahmoud Ahmadinejad, President of the Islamic Republic of Iran, has called for the destruction of Israel and labeled the Holocaust a myth. He has also been testing the limits of diplomacy by pushing the Iranian nuclear program forward in the face of multiple U.N. sanctions; closer, many believe, to his ultimate goal of developing a nuclear bomb.

In December 2006, in response to these

activities, the Jerusalem Center for Public Affairs released an indictment of Ahmadine-jad on the charge of incitement to genocide against the Israeli people. In Canada, B'nai Brith quickly followed suit and issued its own indictment, calling upon the Canadian government to refer Ahmadinejad to the U.N. Security Council for trial. Both the American and Canadian governments have been debating legislation that would accomplish just that, and over the course of the summer Dr. Schwartz and Asper Chair research as-

sistant Chris Donaldson have been probing the possibilities of success that any such indictment might have.

Legal, economic, and military options are being debated as possible responses to the threat that many states perceive in light of the Iranian nuclear program and the rhetoric that accompanies it, and Dr. Schwartz and Mr. Donaldson hope to make some contribution to this crucial discussion. Future plans may include making a submission to any parliamentary committees that study the matter in the fall.

# **PUBLICATIONS**

The Asper Review of International Business and Trade Law is the only Canadian law journal dedicated to the subjects of international business and trade law. The journal addresses issues of interest to Canadians, practitioners, and students of international business law and international trade law around the world.

The journal is currently in its seventh year of publication. Volume VI of the Asper Review, released in July 2007, focuses on health issues, including a proposal to stimulate pharmaceutical innovations and an analysis of the barriers to exporting generic drugs to develop-

ing countries. As well, Volume VI studies Internet and e-commerce issues, such as the regulation of spam and the relationship between file-sharing and copyright infringement. This volume also contains selections from public record documents, including both a Panel decision on the Agreement on Internal Trade and a NAFTA decision.


Volume VII, forthcoming in 2007, continues discussion on Internet and e-commerce issues. This volume covers a variety of other international business and trade topics as well, including an analysis of China's attempt to join the WTO, a review of U.S. laws on securities, an appraisal of the sanitary and phytosanitary measures at the WTO, and an examination of empirical studies of patent law.



Inderneath the Golden Boy, Volume V, is proceeding towards publication later this year. The series reviews recent developments in Manitoba legislation, and explores wider issues of legislative process and reform. Dr. Bryan Schwartz inaugurated the project, and continues to serve as its general editor.

Volume V will feature detailed profiles of eight recent Manitoba statutes, including the debates that surrounded their origin and passage. In addition, Professor Debra Parkes will comment on the review of Manitoba's Employment Standards Code. Dr. Schwartz and this year's senior student editor, Andrew Buck, will explore four dimensions of reform to legislative

process in Manitoba, including fixed election dates, controlling partisan advertising by incumbent governments, reforming the process of calling public inquiries, and restricting the governing party's discretion to call sittings of the House.



Underneath the Golden Boy is part of a trio of annual publications issued by the Faculty of Law. The Asper Review works in close cooperation with UTGB as well as the Manitoba Law Journal. The Shelley M. Weiss Publications Office now houses all three publications, and student assistants and editors working together have found the exchange of ideas and resources to enhance both the efficiency and enjoyability of the experience. Equipment and software purchased with Asper Chair resources is shared whenever possible with the creators of the other two publications.

The authors discuss the issues surrounding the possibility of constructing a hydro-electric transmission line to the east of Lake Winnipeg, with a focus on its impact on the bid for a UNESCO World Heritage Site in this area, as well as the implications of Minnesota's recently passed Bill SF2096.
